Bill Wrigley, Jr. is Chairman of the Board, President and Chief Executive Officer of the Wm. Wrigley Jr. Company, the world's largest manufacturer of chewing and bubble gums and a recognized leader in the confectionery category, with annual sales over \$4 billion. He has held the positions of President and Chief Executive Officer since 1999, serves as Director on the Company's Board since 1988, and was elected Chairman in 2004.

The great-grandson of the founder, Bill is the fourth generation of his family to head this global organization. Since joining the Wrigley Company in 1985, he has held several key management positions impacting every aspect of the business and his leadership has contributed significantly to Wrigley's growth in all geographic regions.

Outside the company, Bill serves in a number of professional capacities. He is a director of the Grocery Manufacturers of American, Inc., and a member of their Executive Committee. He serves on the Foundation Board and the Compensation Committee of the not-for-profit Evanston Northwestern Healthcare Corporation, and is a trustee of Northwestern University.

Additionally, Bill is a member of the Civic Committee of the Commercial Club of Chicago and the Chicago Chapter of the Young President's Organization.

Bill Wrigley, Jr. earned his Bachelor's degree in economics from Duke University in 1985, attended the Wharton School of Business Advanced Management Program in 1994, and was a member of the inaugural class of the Henry Crown Fellowship Program.
