Before joining Harris Associates in 1986, Mr. Raitt was an Investment Officer in the Private Placement Group with Northwestern Mutual Life Insurance Company doing work on LBO, energy and other private equity financings.

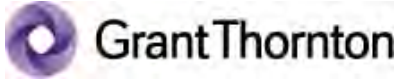
