Before joining Morningstar in 1996 as a stock analyst, Cooley was a bank examiner for the Federal Deposit Insurance Corporation (FDIC), where he focused on credit analysis and asset-backed securities. He has a bachelor's degree in economics and social science and a master's degree in history from Illinois State University.
