Chris Pieszko is Senior Vice President – Finance Strategy, McDonald's Corporation. In this role, Chris is responsible for evaluating and executing optimal ownership structures in the Company's international markets.

Prior to his current role, Mr. Pieszko was Senior Vice President, McDonald's Global Real Estate and New Business Development from 2001 – 2004. This role involved developing strategic plans for new restaurant growth; the relocation, rebuild and re-imaging of existing restaurants; and leveraging the Company's real estate portfolio. In addition, the New Business Development group pursued several new business opportunities, including the global Wi-Fi initiative.

Mr. Pieszko was Senior Vice President and Corporate Controller, from 1996 to 2001, where he was responsible for the Corporate and worldwide Accounting functions. In this role he worked very closely with the Audit Committee of the Board of Directors.

Mr. Pieszko began his career with McDonald's in 1978 as Accounting Supervisor, and moved through various positions in the financial organization. In 1989 he was named Assistant Vice President; Real Estate Accounting, and from 1994 to 1996 served as Vice President – U.S. Controller and Assistant Corporate Controller.

Mr. Pieszko graduated with a Bachelor of Science Degree in Commerce from De Paul University. He is a member of the American Institute of Certified Public Accountants and the Illinois Certified Public Accountants Society. He also serves on the De Paul University Advisory Board for the College of Commerce and on the Administrative Committee of McDonald's Employee Benefit Plans.

Before joining McDonald's, Mr. Pieszko worked as a Staff Accountant at Peat, Marwick & Mitchell and prior to that at the firm of Veatch, Rich & Nadler.

McDonald's awarded Mr. Pieszko with the President's Award in 1979 and the Golden Arch Partner Award in 1998 for his continuous contributions and commitment to McDonald's.

He is a native of Chicago and resides with his family in the western suburbs.
